Parent/Guardian Commitment:

- i. I will not force my child to participate in alpine ski racing
- **ii.** I (and my guests) will be a positive role model and encourage sportsmanship by showing respect and courtesy and by demonstrating positive support for all athletes, coaches, officials and spectators at races, training sessions, and club events.
- **iii.** Furthermore, I will, at all times, behave respectfully towards coaching staff, volunteers, officials, hill staff and other clubs.
- iv. I will remember that my child competes in alpine ski racing for their enjoyment, not mine.
- **v.** I will encourage my child to play by the rules and to resolve conflicts without resorting to hostility or violence.
- vi. I will teach my child that doing one's best is as important as winning.
- vii. I will respect and show appreciation for coaches, volunteers and officials.
- viii. I agree to abide by the policies and procedures of the Wentworth Ski Racing Club.
- ix. I will refrain from negative communication with players, coaches, officials or volunteers.
- **x.** I recognize the authority of the coaching staff and that they have the final decision regarding any athlete's ability to participate in training and/or competition.
- xi. I will not publicly disparage WSRC, its staff or representatives or Ski Wentworth at any time.
- **xii.** I will not go inside the timing office or inside the racecourse, unless in an authorized volunteer position.
- xiii. I will comply with deadlines with regards to registration and event fees.
- **xiv.** If leaving the hill during training hours or leaving cell coverage, provide coaches with contact information or arrange for an alternate guardian contact.
- xv. I agree to abide by the 24-hour rule: When an issue occurs and a party has a resulting complaint to make or issue to be resolved, they are asked to wait 24 hours, then put the issue in writing and submit it to the appropriate party. Whether this issue is labelled as coaching error, team mate interference, parent conflict or any other of a number of possible situations, it is very important that all parties involved take the full 24 hours to remove or decrease the emotional element so that the actual issue can be resolved quickly, in a civilized manner, and to everyone's satisfaction.

I understand and agree that failure to comply with this Code of Conduct may result in disciplinary action in accordance with the Discipline Policy of the Wentworth Ski Racing Club. Such action may result in the member losing the privileges that come from membership in Wentworth Ski Racing Club, including the opportunity to participate in Wentworth Ski Racing Club activities. In the case of parent/guardian infractions, this can apply to both the parent or guardian and their athlete(s) depending on the severity and frequency of infractions.

I have read and understand the WSRC Parent / Guardian Code of Conduct and agree to abide by it on behalf of me and all other parents/guardians of my child (children). I further agree to abide by WSRC's discipline policy and procedures in the event of a complaint or report of behaviour not in accordance with this Code of Conduct.
